STEFANIA ACHELLA is Associate Professor of Moral Philosophy at the University of Chieti-Pescara, where she teaches Ethics. She is currently working on the relationship between philosophy and biology in the nineteenth century, on the concepts of life and corporeity in classical German philosophy, and on the contributions of Feminism to the philosophical debate. MARIAFILOMENA ANZALONE is Senior Researcher of Moral Philosophy at the University of Basilicata. Her main research interests concern: the category of subjectivity in the Hegelian philosophy (*Volontà e soggettività nel giovane Hegel*, Luciano, 2008; *Forme del pratico nella psicologia di Hegel*, Il Mulino, 2012), his reconfigurations in the medical anthropology of V. von Weizsacker and in J. Butler philosophy; the theme of the moral conscience in the ethical sentimentalism and rationalism. Among her most recent writings: *Simpatia* (2020); *Lettori, spettatori, giudici. Immaginazione letteraria e abilità morali in Adam Smith e Martha C. Nussbaum* (2020); „*Das Lob der Frauen*“. *Hegel und das ästhetische Ideal Schillers* (2021).

RAFFAELE CARBONE is Researcher in History of Philosophy at the Federico II University in Naples and “Directeur de programme” at the Collège International de Philosophie in Paris. He was a fellow at the University of Paris 1 Panthéon-Sorbonne, adjunct professor at the Paul Valéry University-Montpellier 3 and visiting scholar at the Collegium de Lyon and at the Centre Marc Bloch in Berlin. His research specializes in modern philosophy, in the reception of modern thinkers in the 20th century and in Critical Theory. Among his latest publications: *La vision politique de Malebranche* (Garmier 2018), *Ragione, razionalità e razionalizzazione in età moderna e contemporanea*, ed. by (FeDOA 2020).

LILLIAN CICERCHIA is Post-Doc at the Institute of Philosophy at the Free University of Berlin. She received her PhD in Philosophy from Fordham University in New York City in 2020. Her areas of specialization are political philosophy, feminist philosophy, and critical theory. Her research is about capitalism, structural injustice, and the intersection of the two. She focuses on how social domination in the basic structures of our society affects the kinds of oppression that social groups experience. Her work also asks how contexts of structural injustice frame the way that we think about our normative criteria for justice in terms of democratic rights and participation. LEONARDO DISTASO is Associate Professor of Aesthetics at the Federico II University of Naples. He is the author of numerous essays and articles in Italian and international journals; he has dealt with the philosophy of music, contemporary aesthetics and, in the last years, with aesthetic aspects in critical theory. PIERGIORGIO DONATELLI is Full Professor of Moral Philosophy at Sapienza University of Rome. His main areas of interest are the theory and history of ethics, bioethics and new technologies. ANNA DONISE is Full Professor of Moral Philosophy at the University of Naples Federico II. Her research focuses on neo-Kantianism (Rickert), phenomenology (Husserl, Scheler, Jaspers), the concept of “Value” and that of “Empathy”. She is presently working on the role of the imagination and of the emotional sphere in determining actions. She is the author of many volumes and essays and has translated several works by Heinrich Rickert, Edmund Husserl and Karl Jaspers into Italian. Her recent publications include the book *Critica della ragione empatica. Fenomenologia dell'altruismo e della crudeltà* (Il Mulino 2020).

FRANCESCA FORLÈ is Post-doc Fellow at the Faculty of Philosophy, Vita-Salute San Raffaele University – Milan and guest lecturer at the Faculty of Psychology at the same institution.
