LUIGI AZZARITI-FUMAROLI is an Associate Professor of Theoretical Philosophy at Pegaso Telematic University. He has edited the Italian editions of works by Derrida, Baumgardt, Hegel, Maimon, and Merleau-Ponty.

CAROLA BARBERO is Professor of Philosophy of Language and Philosophy of Literature at the University of Turin. Her research interests include empty names, the metaphysics and ontology of fictional entities, emotions, the paradox of fiction, the phenomenology of reading, and the distinction between literary and ordinary language. She has been visiting researcher at the University of Auckland (2007) and visiting professor at ETH Zurich (2020). She is the author of numerous essays published in international journals. Among her books: *Madame Bovary: Something Like a Melody* (AlboVersorio, 2005), *Chi ha paura di Mister Hyde?* (Il Melangolo, 2010), *La biblioteca delle emozioni* (Ponte alle grazie, 2012), *Filosofia della letteratura* (Carocci, 2013), *L'arte di nuotare* (Il Melangolo, 2016), *Significato* (with S. Caputo, Carocci 2018), *La porta della fantasia* (Il Mulino, 2019) and *Quel brivido nella schiena. I linguaggi della letteratura* (Il Mulino, 2023). She is a member of the following research groups: LabOnt, LLC, and Mumble.

MIGUEL DE BEISTEGUI is Research Professor of Philosophy at the Catalan Institute of Research and Advanced Studies (ICREA), Professor in the Department of Political and Social Sciences, Universitat Pompeu Fab-

ra, Barcelona, and Honorary Professor at the University of Warwick, UK. He is the author of fourteen books, including *Jouissance de Proust. Pour une esthétique de la métaphore* (2007), *Aesthetics After Metaphysics. From Mimesis to Metaphor* (Routledge, 2012), *L'élan du désir. Pour une éthique de la volupté* (Éditions du Seuil, 2021).

FRANCESCO CAMPANA is a Marie Skłodowska-Curie Post-Doctoral Global Fellow at the University of Padua, the New School for Social Research in New York, and the Free University of Berlin. His current project is entitled *PolArt – Political Art: Understanding the Function of Art in the Contemporary Social Space Through a New Interpretation of Classical German Philosophy*. He studied and worked in Padua, Jena, Bochum, New York, Berlin, Naples, and Rome. His main research interests include Classical German Philosophy, Philosophy of Art, and Philosophy of Literature. He has published the book *The End of Literature, Hegel, and the Contemporary Novel* (Palgrave Macmillan 2019).

CARLA CANULLO teaches Philosophy of Religion at the University of Macerata where she is also Chair of Intercultural Hermeneutics. Her research is devoted to French philosophy and her publications include *Coscienza e libertà. Itinerario tra Maine de Biran, Lavelle, Le Senne* (Napoli 2001); *La fenomenologia rovesciata. Together with Johann Michel she edited *The Renewal of Hermeneutics: With Paul Ricœur And Beyond* (Discipline Filosofiche 2020) and *Renewing Hermeneutics. Thinking with Paul Ricœur; Renouveler l'herméneutique. Penser avec Paul Ricœur* (Roma 2021). She dedicated the volume *Il chiasmo della traduzione* (Milano 2017) to translation as a method of Intercultural Hermeneutics

ANNALISA CAPUTO is an Associate Professor of Theoretical Philosophy at the University of Bari where she teaches Philosophical Hermeneutics and Didactics of Philosophy. She is founder and editor of the international journal "Logoi.ph" (www.logoi.ph) and author of numerous works on Nietzsche, Heidegger and Ricœur, including: *Pensiero e affettività. GIANLUCA CUOZZO is Full Professor of Theoretical Philosophy at the University of Turin (Italy), where he teaches Theoretical Philosophy, Philosophy of Religion and Fundamentals of Ecology. He is the President of the Società Cusaniiana (Torino), of the Centro Studi Interdisciplinari sul Pensiero e l'Arte del Rinascimento (Torino-Parma), of the Fondazione Centro Studi "Augusto Del Noce", and serves as Editor-in-chief of the journal "Filosofia". His research interests span the fields of philosophy of nature, philosophy of history (Löwith and Benjamin), the intersections between philosophy and literature (Auster, Ballard, DeLillo, McCarthy) and between art and philosophy in the fifteenth and sixteenth centuries, and ecological thought. Among his latest monographs are *Etica dei resti* (2020), *L'eccezione in immagine. Storia, arte pittorica e cinematografia in W. Benjamin* (2023), *Immagini viventi. Un percorso filosofico tra ritratti, volti e facce* (2023).

CLAUDIO D'AURIZIO is expert (cultore della materia) for the Chair of Theoretical Philosophy at the University of Calabria, where in 2019 he obtained a doctorate in cotutorship with the Université de Reims Champagne-Ardenne. He is editorial secretary of *L'inconscio. Rivista Italiana di Filosofia e Psicoanalisi* and he is the author of the essay *Una filosofia della piega. Saggio su Gilles Deleuze* (Mimesis, 2024). He translated and edited the Italian edition of David Lapoujade, *Deleuze. I movimenti aberranti* (Mimesis, 2020) and Alain Badiou, *L'antifilosofia I. Nietzsche. Il seminario 1992-1993* (Mimesis, 2022).

CAMILLA DE SIMONE is a Ph.D. candidate in Human Sciences (Philosophy curriculum) at the "G. D'Annunzio" University of Chieti-Pescara and the Friedrich-Alexander-Universität Erlangen-Nürnberg. Her research explores the philosophical notion of literary realism, particularly through the work of Erich Auerbach. She is the author of the article "An Aesthetic of Responsibility: Mikhail Bakhtin and the Role of the Author in the Emergence of the Hero as an Autonomous Subject" ("Estetica: Studi e ricerche", 2023). Additionally, she contributed to the volume *The professions of communicating: past, present, future* (Quasar) with a reflection on the philosophical nature of communication from an Heideggerian perspective,

entitled “A Heideggerian reading of media in the age of Communication” (2023). She also wrote the essay, “Erich Auerbach’s Montaigne and the experiential value of mimesis” (2024), featured in the volume *Mimesis and Realism* (Istituto Italiano per gli Studi Filosofici Press). In June 2023 she was appointed as teaching assistant in Theoretical Philosophy at the University G. D’Annunzio. She is a member of the Italian Philosophical Society, serving on the boards of the Society for the History of the Humanities and the international research group L&gend.

SILVANO FACIONI is an Associate Professor of Theoretical Philosophy at Sapienza - University of Rome. He has translated works by Jacques Derrida, Emmanuel Lévinas, Michel de Certeau, and Claude Lévi-Strauss into Italian. He is a member of the Advisory Board of the *Oxford Literary Review*. Together with Renato Boccali he directs the “Macula” series at the publisher Mimesis and together with Roberto Revello, he directs the “Mnēsis” series for the same publisher. He has published numerous works devoted to the work of Jacques Derrida including: *Derridario. Dizionario della decostruzione* (together with Simone Regazzoni and Francesco Vitale, il melangolo, 2012) and *Ritmografie. Jacques Derrida, la letteratura, la genere* (il melangolo, 2021).

SIMONE FURLANI teaches Theoretical Philosophy at the University of Udine. His research, conducted between the Universities of Padua, Pisa, Munich and Münster, concerns the concepts of reflection and difference from Classical German Philosophy to contemporary philosophy and art. Among his publications: *Verso la differenza. Contraddizione, negazione e aporie dopo l’idealismo* (2011), *L’immagine e la scrittura. Le logiche del vedere tra segno e riflessione* (2016) and *La differenza tedesca. Considerazioni sulla filosofia trascendentale* (2019).

DANILO MANCA is an Assistant Professor in Theoretical Philosophy at the University of Pisa. He deals with Classical German Philosophy, Phenomenology, Philosophy of Literature, Philosophy of Mind, and Metaphilosophy. He has published several articles and book chapters in Italian and English, and three books: *Esperienza della Ragione. Hegel e Husserl in dialogo* (ETS 2016), *La disputa su ispirazione e composizione. Valéry fra Poe e Borges* (ETS 2018) and *Hegel, Husserl e il linguaggio della filosofia* (ETS 2023). He has also coordinated two research projects: an international one, funded by the Italian Institute for German Studies, on the “Mediterranean Roots of European Culture”, and a second, funded by

the University of Pisa, on “The Reality of the Future. Models and History for the Predictive Capacity of Mind”. Finally, he is the editor-in-chief of the scientific journal “Odradek. Studies in Philosophy of Literature, Aesthetics, and New Media Theories”.

ALESSANDRO MONTEFAMEGLIO is a Ph.D. candidate in Philosophy at “Vita-Salute San Raffaele University” in Milan, where he is working on a research project on Giambattista Vico and Baroque philosophy. His interests focus on modern philosophy, particularly of the Baroque period, and contemporary philosophy, especially French post-structuralism and Gilles Deleuze. He is a member of the SIE (Italian Society of Aesthetics) and the SiFiT (Italian Society of Theoretical Philosophy), a member of the Diaporein research center (UniSR), and a member of the Editorial Board of the journal *Aisthesis*. In 2023, he published *La filosofia dello spazio di Gilles Deleuze* (Mimesis).

GIAMPIERO MORETTI is Full Professor of Literary Criticism and Comparative Literatures at the University of Naples “L’Orientale”. He has written and translated several works with a particular focus on aesthetic philosophy. His latest volume on the subject is *Estetica e Comparatistica*, Brescia 2021.

ISABELLE OST is Full Professor at UCLouvain Saint-Louis Brussels. She heads the IRIS-L research institute as well as the “Centre Prospéro. Langage, image et connaissance”. Specialist in the works of Samuel Beckett and Gilles Deleuze, her research and publications focus on the relationship between philosophy and literature. She is also interested in contemporary French literature, in particular the links between literature and cartography. She is the author of *Samuel Beckett et Gilles Deleuze: cartographie de deux parcours d’écriture* (PUSL, 2008). She also edited the volumes *Cartographier. Regards croisés sur des pratiques littéraires et philosophiques contemporaines* (PUSL, 2018); *Jacques Rancière, aux bords de l’histoire*, Kimé, 2021, together with S. Laoureux); *Décrire la carte, écrire le monde* (Phantasia, vol. 13, 2023, together with A. d’Avout).

PHILIPPE SABOT is Full Professor of Philosophy at the University of Lille (UMR 8163 Savoirs, Textes, Langage), and President of the Centre Michel Foucault since 2017. His research interests focus on the relationships between philosophy and literature, on Foucault’s thought and his legacy in contemporary philosophy and also currently on vulnerability and

healthcare issues among older people. He has published *Pratiques d'écriture, pratiques de pensée. Figures du sujet chez Breton, Bataille et Leiris* (2001), *Philosophie et littérature. Approches et enjeux d'une question* (2002), *Lire "Les Mots et les choses"* (2014), *Littérature et guerres. Sartre, Malraux, Simon* (2015), *Le Même et l'Ordre. Michel Foucault et le savoir à l'âge classique* (2015). He also contributed to the edition of the works of Michel Foucault in the "Bibliothèque de la Pléiade" (2015). He recently edited *Phénoménologie et psychologie* (2021) and a book on *Michel Foucault. Discours et politiques de l'identité* (2022).

CHIARA SCARLATO is a Postdoctoral Fellow in Theoretical Philosophy at the "G. d'Annunzio" University of Chieti – Pescara. Her research interests include the relationship between philosophy and literature, the phenomenology of reading, and topics in gender studies. She is the author of *Attraverso il corpo. Filosofia e letteratura in David Foster Wallace* (Mimesis, 2020) and *Il discorso filosofico intorno alla letteratura. Percorsi teorici nel pensiero francese* (Rosenberg & Sellier, 2024), as well of numerous essays published in Italian and international journals and books. She is member of the international research group "L&gend. Literature and Gender Identity".

FRANCESCO TERENCE is a Postdoctoral Fellow in the Department of Philosophical, Pedagogical and Economic-Quantitative Sciences at the University "G. D'Annunzio" of Chieti. After obtaining his MA from the University of Chieti, his research has focused on "The content of John Locke's Journals and pocket memorandum Books" and his doctoral thesis examines the demonstration of the existence of God in Locke's thought with a focus on the unpublished entries of Locke's journals. He is currently working on the relation between vulnerability and AI.

PAOLO VALORE teaches Gnoseology at the University of Milano. He has taught Theoretical Philosophy at the Faculty of Engineering at the Politecnico di Milano and Philosophy of Social Objects at Bocconi University. He is Visiting Scholar at NYU (New York), Rutgers (New Brunswick), Higher School of Economics (Moscow), Complutense (Madrid), Columbia University (New York). He has twice received a Fulbright grant from the U.S. Department of State and headed the inter-university project "Onto-ForMat." Among his books: *Fundamentals of Ontological Commitment, L'inventario del mondo. Guida allo studio dell'ontologia, La sentenza di Isacco. Come dire la verità senza essere realisti, Rappresentazione, riferimento e realtà* and *Trascendentale e idea di ragione*.

ANDREA VELARDI is Full Professor of Philosophy of Cognitive and Emotional Processes at the University Niccolò Cusano in Rome where he is also Coordinator of the Master's degree in Applied Philosophical Sciences and Vice-Director of the Department of Humanities, Motor and Educational Sciences. He is Visiting Associate Professor at Xenophon College London and Coordinator of an international network about Emergent Phenomena. Among his publications: *La barba di Platone. Quale ontologia per gli oggetti materiali?* (2012); *La versione del mondo. Perché non è possibile un realismo senza soggetto* (2018); *Subject and world. From deconstruction to reconstruction of the foundations of philosophy* (in press); *Emergentist Metaphysics for Mind and World* (in press).

SIMONA VENEZIA is an Associate Professor of Theoretical Philosophy at the Department of Humanities of the University of Naples Federico II. She gained a Ph.D. in Philosophy in Naples, and also studied in Germany at the Universities of Heidelberg, Tübingen and Freiburg i. Br. She is member of the advisory Board of the Martin Heidegger Society and of several academic institutions. She currently teaches Theoretical Philosophy and Philosophical Hermeneutics and holds several institutional positions in the aforementioned Department. Her fields of interest are contemporary philosophers such as Heidegger, Wittgenstein, Nietzsche and Gadamer, and essential themes of contemporary Theoretical Philosophy (above all hermeneutics, ontology, metaphysics, questions concerning time and technology, and the relationship between philosophy and poetry).
